Addendum No. 3

This Addendum No. 3 to the Request for Proposal - Site Selection related to the Regional Academic Health Center in the Lower Rio Grande Valley of Texas for the Board of Regents of The University of Texas System ("Addendum") is issued effective as of March 20, 1998 by The University of Texas System ("University") to modify and amend that certain Master Request for Proposal - Site Selection related to the Regional Academic Health Center in the Lower Rio Grande Valley of Texas for the Board of Regents of The University of Texas System, RFP No. 98-1, issued January 5, 1998, as previously amended by Addendum No. 1 issued February 3, 1998 and Addendum No. 2 issued February 13, 1998 (collectively the "RFP"). Unless otherwise defined herein, all capitalized terms used in this Addendum shall have the meanings assigned to them by the RFP.

University hereby amends the RFP as more specifically set forth below:

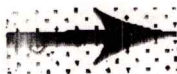

Public Hearings

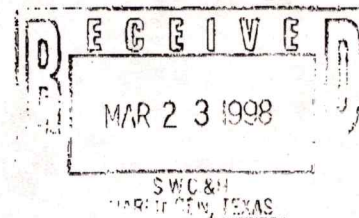
The University of Texas System has issued Addendum No. 3 to the Request for Proposal. A true and correct copy of the Addendum is attached for your information.
